## *Draft Terms of Reference (ToR) for hiring of Assistant Civil Engineers (ACE)*

### **Project background:**

1. The Government of Assam (GoA) through Government of India (GoI) has received a loan from the World Bank for implementation of Assam Agribusiness and Rural Transformation Project (APART). The Project Development Objective (PDO) is to “to add value and improve resilience of selected agriculture value chains, focusing on smallholder farmers and agro-entrepreneurs in targeted districts of the State of Assam”. Assam Rural Infrastructure and Agricultural Services (ARIAS) Society is the apex coordinating agency for the project. The project activities will be spread over a period of seven years, involving eight line Departments of Government of Assam including their Directorates/Agencies/Commissionerates. ARIAS Society now intends to utilize a part of loan for modernization & up-gradation of 75 existing Rural Agricultural Markets. The Assam Rural Infrastructure and Agricultural Services (ARIAS) Society intends to hire **10 (ten) numbers of Assistant Civil Engineers hereinafter called ‘ACE’** purely on contractual basis under Assam State Agricultural Marketing Board (ASAMB), Ulubari, Guwahati- 7, Assam for the aforesaid assignments. Depending on the requirement, the ACE will be posted in ASAMB as well as in different Regulated Market Committees under ASAMB situated within the 16 (Sixteen) APART project districts.
2. There are four components to the APART. **The first component is Enabling Agri enterprise Development**, with sub components being (i) enhancing state capacity to attract private investments, (ii) setting up of an Enterprise Development and Promotion Facility (EDPF)(iii) setting up of an Agribusiness Investment fund (iv) establishing stewardship councils. **The second component is Facilitate Agro Cluster Development** with sub-components being- (i) support establishment of Industry Associations (IAs), (ii) supply chain support. **The third component is Fostering Market Led Production and Resilience Enhancement** with sub components being (i) promoting climate resilient technologies and their adoption (ii) facilitating market linkages through market intelligence and product aggregation (iii) Facilitating access to and responsible use of financial services. **The fourth component is project Management, Monitoring and Learning.**
3. The project will achieve the proposed PDO by: (i) enabling investments in agri-enterprises, improving the investment environment and investment promotion, facilitating access to finance for agribusiness entrepreneurs, and, where appropriate, pushing for process, regulatory changes; (ii) facilitating the growth of agri enterprise clusters to increase competitiveness, revenue and employment growth; and

supporting development of modern supply chains; and (iii) fostering the development of climate resilient production clusters, and improving producer access to knowledge, technologies and infrastructure so that they are able to respond to market opportunities and climate variability.

4. The construction activities in project districts of APART will include - construction of agricultural markets, renovation /refurbishment of Operational Project Implementation Unit of ASAMB, rehabilitation of access roads connecting the proposed markets. These works will be executed by the PWRD/concerned line departments.
5. The ASAMB is one of the implementing agencies under Agriculture Department, Govt. of Assam for implementation of APART. To perform various project activities and to coordinate between the Project Coordination Unit (PCU) in ARIASS and respective line Department/ Directorate/Commissionerate/ Agency, one Operational Project Implementation Unit (OPIU) has been constituted under ASAMB. The ASAMB through its OPIU shall have to perform the following broad activities in the matter on up-gradation & modernization of agricultural markets within the selected districts:
  - i) To provide necessary support to the PWRD for the selected agricultural markets up-gradation & modernization programme.
  - ii) To supervise the construction works of up-gradation & modernization of agricultural markets jointly with the PWRD for maintaining quality & specification of works.
  - iii) To certify the construction bills against the works of up-gradation & modernization of agricultural markets jointly with the PWRD for consideration of payment to the contractor.
6. In view of the envisaged civil works, it is intended to hire the services of 10 (Ten) numbers of ACEs to support the OPIU, ASAMB for successful completion of the assignments as stipulated in the Project Implementation Plan (PIP) of APART.

## Scope of Position:

7. The ACE, under the supervision of the Joint Chief Executive Officer (Technical), will *inter alia* support the OPIU, ASAMB mostly perform regular/periodical supervision of construction works to be taken up for up-gradation & modernization of agricultural markets within the selected districts under APART ensuring compliance to the technical requirements related to civil works planned under the project. They will also ensure certification of bill against the quantity of works actually executed by the contractor as per approved specification. In addition to the above, the ACE will support the OPIU, ASAMB in reviewing the Detailed Project Reports (DPRs), Drawings, Structural Designs, Monitoring, Documentation etc. relevant or incidental to the agricultural markets up-gradation & modernization programme.

## 8. Essential Qualifications, Experience and Skill Set:

- a) **Educational Qualification:** At least a Bachelor Degree in Civil Engineering from a recognized institute/University (Degrees obtained through distance education shall not be accepted).
- b) **Working Experience:** At least 3years of professional experience in Civil Engineering including in engineering design and field execution of civil works of varied nature. (However, in case of insufficient applications from candidates having 3 years experience, the ASAMB reserves the right to relax the experience requirement criteria up to 1 year, but with a reduced remuneration package).
- c) **Computer Skills:** The ACE must have adequate knowledge and experience of working with AutoCad and other similar engineering applications, MS Word/Excel/Power Point/Project and Internet based applications.
- d) **Language:** Working knowledge of Hindi and high level of fluency in English.

## 9. Desirable Qualifications, Experience, Skills etc.:

- a) Candidates having Post Graduate Degree in Civil Engineering will be given preference;
- b) Candidates having experience of working in externally aided projects or public sector agencies will be given preference;
- c) Knowledge of Assamese/Bengali is desirable, but not essential;
- d) Good social, analytical and planning skills is desirable; the candidate must demonstrate initiative, synthesis, organization and personal dynamism, be self-motivated and should possess ability to work independently as well as in teams.

10. **Age:** Age of the candidate should not be more than 40 years as on **1<sup>st</sup> July, 2018**.

11. **Key Job Responsibilities:** The ACE will support the Joint Chief Executive Officer (Technical) and OPIU, ASAMB in –

- i) Studying the design, drawings, DPRs etc prepared by the architecture/consultancy firm hired by the project for the agricultural markets up-gradation & modernization programme before execution.
- ii) Carrying out regular supervision of works at site jointly with PWRD Engineers for reviewing the progress of works, verification of the construction/renovation works for compliance with specified technical standards, approved drawings & designs etc. and submit monthly progress reports with chronological photographs of executed works to the Chief Executive Officer on periodic basis while on day to day basis and for operational matters ACE will report to the Joint Chief Executive Officer (Technical), ASAMB.

- iii) To ensure that the civil work activities of the agricultural markets up-gradation & modernization programme are progressing as per the Procurement Plan/Annual Work Plans/relevant Contract Agreements and take all possible measures to keep the progress of the work on time and as per plan.
- iv) To inform the OPIU, ASAMB immediately regarding happening of any unseen incidents and to suggest remedial measures of such incidents.
- v) To verify the construction bills/vouchers submitted by the contractors and endorsing the same jointly with PWRD Engineers for releasing of payments.
- vi) Any other task as and when assigned by the OPIU, ASAMB.
- vii) **Travel Requirements:** The ACE will be required to undertake regular field-visits and tours as per the project requirements. In case of tours, prior approval of the Chief Executive Officer, ASAMB must be obtained before performing the same by the ACE. However, the ACE will have to arrange his/her own conveyance facility for attending the work site in their respective place of posting.

## Duration of assignment & tenure etc:

12. The contract period of the ACE is intended for entire duration of the APART. However, continuity of ACE beyond initial 1 (one) year will depend upon his/her performance. The Resignation/Termination shall be as per the prevailing project rules.

## Remuneration and payment terms:

13. Depending on the qualifications, experience, competency, and also the remuneration/pay package of the last assignment, the consolidated fixed monthly remuneration of the ACE will be determined and mutually agreed, which could be in the range of **Rs. 4.80 lakhs to Rs. 5.40 lakhs per year**. However, for outstanding candidates the range may be extended to some extent. *87% of the remuneration will be paid as fixed salary while 13% will be linked to performance.* This remuneration shall be inclusive of all taxes, health/service related insurance, all allowances, cost of food, accommodation and conveyance to attend the work site etc at the place of posting within the project districts. Taxes as applicable will be dealt with as per applicable laws. The remuneration will be enhanced on an annual basis, based on the prevailing project rules.
14. Travelling, Boarding & Lodging expenses for approved official tours outside the place of posting will be reimbursed as per prevailing project rules.
15. The ACE will be eligible for a paid Leave of 12 working days per year, excluding two restricted holidays. Leave of absence for more than total 14 (fourteen) working days in a year will be treated as leave without pay. Nevertheless, casual leave of more than 5 working days at a stretch will not be granted. However, in exceptional circumstances, CEO (ASAMB) may relax this condition.
