1. The Government of Assam through the Government of India (hereinafter called "Borrower") has received financing from the International Bank for Reconstruction and Development (IBRD) in the form of a "loan" (hereinafter called "loan") towards the cost of **Assam Agribusiness and Rural Transformation Project (APART). The Assam Rural Infrastructure and Agricultural Services (ARIAS) Society**, an implementing agency of the Client intends to apply a portion of the proceeds of this loan to eligible payments under the contract for which this Request for Proposals (RFP) is issued. Payments by the Bank will be made only at the request of the ARIAS Society and upon approval by the Bank, and will be subject, in all respects, to the terms and conditions of the financing agreement. The financing agreement prohibits a withdrawal from the loan account for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import, to the knowledge of the Bank, is prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations. No party other than the Client shall derive any rights from the financing agreement or have any claims to the proceeds of the loan.
2. The Client now invites proposals to provide the following consulting services (hereinafter called "Services"): **"Hiring of Technical Consulting Services for: "SETTING UP & MANAGING THE STATE PROJECT MANAGEMENT UNIT (SPMU) OF ASSAM MILLETS MISSION (AMM) UNDER ASSAM AGRIBUSINESS AND RURAL TRANSFORMATION PROJECT (APART) FOR A PERIOD OF TWO YEARS"**. More details on the Services are provided in the Terms of Reference (Section 7).
3. A firm will be selected under **Quality and Cost Based Selection (QCBS)** procedures and in a **Full Technical Proposal (FTP)** format as described in this RFP, in accordance with the policies of the Bank detailed in the Bank's "Regulations for IPF Borrowers" July 2016 (" Procurement Regulations") which can be found at the following website: www.worldbank.org/procure.

Section 2. Instructions to Consultants and Data Sheet

Instructions to Consultants

A. General Provisions

1. **Definitions**
- (a) "Affiliate(s)" means an individual or an entity that directly or indirectly controls, is controlled by, or is under common control with the Consultant.
 - (b) "Applicable Law" means the laws and any other instruments having the force of law in the Client's country, or in such other country as may be specified in the **Data Sheet**, as they may be issued and in force from time to time.
 - (c) "Bank" means the International Bank for Reconstruction and Development (IBRD) or the International Development Association (IDA).
 - (d) "Borrower" means the Government, Government agency or other entity that signs the *[loan/financing/grant¹]* agreement with the Bank.
 - (e) "Client" means the implementing agency that signs the Contract for the Services with the selected Consultant.
 - (f) "Consultant" means a legally-established professional consulting firm or an entity that may provide or provides the Services to the Client under the Contract.
 - (g) "Contract" means a legally binding written agreement signed between the Client and the Consultant and includes all the attached documents listed in its Clause 1 (the General Conditions of Contract (GCC), the Special Conditions of Contract (SCC), and the Appendices).
 - (h) "Data Sheet" means an integral part of the Instructions to Consultants (ITC) Section 2 that is used to reflect specific country and assignment conditions to supplement, but not to over-write, the provisions of the ITC.
 - (i) "Day" means a calendar day, unless otherwise specified as "Business Day". A Business Day is any day that is an official working day of the Borrower. It excludes the Borrower's official public holidays.
 - (j) "Experts" means, collectively, Key Experts, Non-Key Experts, or any other personnel of the Consultant, Sub-consultant or Joint Venture member(s).
 - (k) "Government" means the government of the Client's country.
 - (l) "in writing" means communicated in written form (e.g. by mail, e-mail, fax, including, if specified in the Data Sheet, distributed or received through the electronic-procurement system used by the Client) with proof of receipt;
 - (m) "Joint Venture (JV)" means an association with or without a legal personality distinct from that of its members, of more than one Consultant where one member has the authority to conduct all business for and on behalf of any and all the members of the JV, and where the members of the JV are jointly and severally liable to the Client for the performance of the Contract.
 - (n) "Key Expert(s)" means an individual professional whose skills, qualifications, knowledge and experience are critical to the performance of the Services under the Contract and whose CV is taken into account in the technical evaluation of the Consultant's proposal.
 - (o) "ITC" (this Section 2 of the RFP) means the Instructions to Consultants that provides the Consultants with all information needed to prepare their Proposals.
 - (p) "Non-Key Expert(s)" means an individual professional provided by the Consultant or its Sub-consultant and who is assigned to perform the Services or any part thereof under the Contract and whose CVs are not evaluated individually.
 - (q) "Proposal" means the Technical Proposal and the Financial Proposal of the Consultant.
 - (r) "RFP" means the Request for Proposals to be prepared by the Client for the selection of

Consultants, based on the SPD - RFP.

- (s) "SPD - RFP" means the Standard Procurement Document -Request for Proposals, which must be used by the Client as the basis for the preparation of the RFP.
- (t) "Services" means the work to be performed by the Consultant pursuant to the Contract.
- (u) "Sub-consultant" means an entity to whom the Consultant intends to subcontract any part of the Services while the Consultant remains responsible to the Client during the whole performance of the Contract.
- (v) "Terms of Reference (TORs)" (this Section 7 of the RFP) means the Terms of Reference that explains the objectives, scope of work, activities, and tasks to be performed, respective responsibilities of the Client and the Consultant, and expected results and deliverables of the assignment.

2. Introduction 2.1 The Client named in the **Data Sheet** intends to select a Consultant from those listed in the Request for Proposals (RFP), in accordance with the method of selection specified in the **Data Sheet**.

2.2 The Consultants are invited to submit a Technical Proposal and a Financial Proposal, or a Technical Proposal only, as specified in the **Data Sheet**, for consulting services required for the assignment named in the **Data Sheet**. The Proposal will be the basis for negotiating and ultimately signing the Contract with the selected Consultant.

2.3 The Consultants should familiarize themselves with the local conditions and take them into account in preparing their Proposals, including attending a pre-proposal conference if one is specified in the **Data Sheet**. Attending any such pre-proposal conference is optional and is at the Consultants' expense.

2.4 The Client will timely provide, at no cost to the Consultants, the inputs, relevant project data, and reports required for the preparation of the Consultant's Proposal as specified in the **Data Sheet**.

3. Conflict of Interest 3.1 The Consultant is required to provide professional, objective, and impartial advice, at all times holding the Client's interests paramount, strictly avoiding conflicts with other assignments or its own corporate interests, and acting without any consideration for future work.

3.2 The Consultant has an obligation to disclose to the Client any situation of actual or potential conflict that impacts its capacity to serve the best interest of its Client. Failure to disclose such situations may lead to the disqualification of the Consultant or the termination of its Contract and/or sanctions by the Bank.

3.2.1 Without limitation on the generality of the foregoing, and unless stated otherwise in the **Data Sheet** the Consultant shall not be hired under the circumstances set forth below:

a. Conflicting Activities (i) Conflict between consulting activities and procurement of goods, works or non-consulting services: a firm that has been engaged by the Client to provide goods, works, or non-consulting services for a project, or any of its Affiliates, shall be disqualified from providing consulting services resulting from or directly related to those goods, works, or non-consulting services. Conversely, a firm hired to provide consulting services for the preparation or implementation of a project, or any of its Affiliates, shall be disqualified from subsequently providing goods or works or non-consulting services resulting from or directly related to the consulting services for such preparation or implementation.

b. Conflicting Assignments (ii) Conflict among consulting assignments: a Consultant (including its Experts and Sub-consultants) or any of its Affiliates shall not be hired for any assignment that, by its nature, may be in conflict with another assignment of the Consultant for the same or for another Client.

c. Conflicting Relationships (iii) Relationship with the Client's staff: a Consultant (including its Experts and Sub-consultants) that has a close business or family relationship with a professional staff of the Borrower (or of the Client, or of implementing agency, or of a recipient of a part of the Bank's financing) who are directly or indirectly involved in any part of (i) the preparation of the Terms of

Reference for the assignment, (ii) the selection process for the Contract, or (iii) the supervision of the Contract, may not be awarded a Contract, unless the conflict stemming from this relationship has been resolved in a manner acceptable to the Bank throughout the selection process and the execution of the Contract.

4. Unfair Competitive Advantage

4.1 Fairness and transparency in the selection process require that the Consultants or their Affiliates competing for a specific assignment do not derive a competitive advantage from having provided consulting services related to the assignment in question. To that end, the Client shall indicate in the **Data Sheet** and make available to all Consultants together with this RFP all information that would in that respect give such Consultant any unfair competitive advantage over competing Consultants.

5. Fraud and Corruption

5.1 The Bank requires compliance with the Bank's Anti-Corruption Guidelines and its prevailing sanctions policies and procedures as set forth in the WBG's Sanctions Framework, as set forth in Section 6.

5.2 In further pursuance of this policy, Consultants shall permit and shall cause their agents (where declared or not), subcontractors, subconsultants, service providers, suppliers, and their personnel, to permit the Bank to inspect all accounts, records and other documents relating to any shortlisting process, Proposal submission, and contract performance (in the case of award), and to have them audited by auditors appointed by the Bank.

6. Eligibility

6.1 The Bank permits consultants (individuals and firms, including Joint Ventures and their individual members) from all countries to offer consulting services for Bank-financed projects.

6.2 Furthermore, it is the Consultant's responsibility to ensure that its Experts, joint venture members, Sub-consultants, agents (declared or not), sub-contractors, service providers, suppliers and/or their employees meet the eligibility requirements as established by the Bank in the Applicable Procurement Regulations.

6.3 As an exception to the foregoing ITC 6.1 and ITC 6.2 above:

a. Sanctions

6.3.1 A Consultant that has been sanctioned by the Bank, pursuant to the Bank's Anti-Corruption Guidelines and in accordance with its prevailing sanctions policies and procedures as set forth in the WBG's Sanctions Framework as described in Section VI, Fraud and Corruption, paragraph 2.2 d., shall be ineligible to be shortlisted for, submit proposals for, or be awarded a Bank-financed contract or benefit from a Bank-financed contract, financially or otherwise, during such period of time as the Bank shall have determined. The list of debarred firms and individuals is available at the electronic address specified **in the Data Sheet**.

b. Prohibitions

6.3.2 Firms and individuals of a country or goods manufactured in a country may be ineligible if so indicated in Section 5 (Eligible Countries) and:

- (a) as a matter of law or official regulations, the Borrower's country prohibits commercial relations with that country, provided that the Bank is satisfied that such exclusion does not preclude effective competition for the provision of Services required; or
- (b) by an act of compliance with a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations, the Borrower's Country prohibits any import of goods from that country or any payments to any country, person, or entity in that country.

c. Restrictions for State-Owned Enterprises

6.3.3 State-owned enterprises or institutions in the Borrower's country may be eligible to compete and be awarded a contract only if they can establish, in a manner acceptable to the Bank, that they: (i) are legally and financially autonomous, (ii) operate under commercial law, and (iii) are not under supervision of the Client.

d. Restrictions for Public Employees

6.3.4 Government officials and civil servants of the Borrower's country are not eligible to be included as Experts, individuals, or members of a team of Experts in the Consultant's Proposal unless:

- (i) the services of the government official or civil servant are of a unique and exceptional nature, or their participation is critical to project implementation; and
- (ii) their hiring would not create a conflict of interest, including any conflict with

employment or other laws, regulations, or policies of the Borrower.

e. Borrower Debarment

6.3.5 A firm that is under a sanction of debarment by the Borrower from being awarded a contract is eligible to participate in this procurement, unless the Bank, at the Borrower's request, is satisfied that the debarment; (a) relates to fraud or corruption, and (b) followed a judicial or administrative proceeding that afforded the firm adequate due process.

B. Preparation of Proposals

7. General Considerations

7.1 In preparing the Proposal, the Consultant is expected to examine the RFP in detail. Material deficiencies in providing the information requested in the RFP may result in rejection of the Proposal.

8. Cost of Preparation of Proposal

8.1 The Consultant shall bear all costs associated with the preparation and submission of its Proposal, and the Client shall not be responsible or liable for those costs, regardless of the conduct or outcome of the selection process. The Client is not bound to accept any proposal, and reserves the right to annul the selection process at any time prior to Contract award, without thereby incurring any liability to the Consultant.

9. Language

9.1 The Proposal, as well as all correspondence and documents relating to the Proposal exchanged between the Consultant and the Client, shall be written in the language(s) specified in the **Data Sheet**.

10. Documents Comprising the Proposal

10.1 The Proposal shall comprise the documents and forms listed in the **Data Sheet**.

10.2 If specified in the **Data Sheet**, the Consultant shall include a statement of an undertaking of the Consultant to observe, in competing for and executing a contract, the Client country's laws against fraud and corruption (including bribery).

10.3 The Consultant shall furnish information on commissions, gratuities, and fees, if any, paid or to be paid to agents or any other party relating to this Proposal and, if awarded, Contract execution, as requested in the Financial Proposal submission form (Section 4).

11. Only One Proposal

11.1 The Consultant (including the individual members of any Joint Venture) shall submit only one Proposal, either in its own name or as part of a Joint Venture in another Proposal. If a Consultant, including any Joint Venture member, submits or participates in more than one proposal, all such proposals shall be disqualified and rejected. This does not, however, preclude a Sub-consultant, or the Consultant's staff from participating as Key Experts and Non-Key Experts in more than one Proposal when circumstances justify and if stated in the **Data Sheet**.

12. Proposal Validity

12.1 **The Data Sheet** indicates the period during which the Consultant's Proposal must remain valid after the Proposal submission deadline.

12.2 During this period, the Consultant shall maintain its original Proposal without any change, including the availability of the Key Experts, the proposed rates and the total price.

12.3 If it is established that any Key Expert nominated in the Consultant's Proposal was not available at the time of Proposal submission or was included in the Proposal without his/her confirmation, such Proposal shall be disqualified and rejected for further evaluation, and may be subject to sanctions in accordance with ITC 5.

a. Extension of Validity Period

12.4 The Client will make its best effort to complete the negotiations and award the contract within the proposal's validity period. However, should the need arise, the Client may request, in writing, all Consultants who submitted Proposals prior to the submission deadline to extend the Proposals' validity.

12.5 If the Consultant agrees to extend the validity of its Proposal, it shall be done without any change in the original Proposal and with the confirmation of the availability of the Key Experts, except as provided in ITC 12.7.

12.6 The Consultant has the right to refuse to extend the validity of its Proposal in which case such Proposal will not be further evaluated.

b. Substitution of Key Experts at Validity Extension

12.7 If any of the Key Experts become unavailable for the extended validity period, the Consultant shall seek to substitute him with another Key Expert. The Consultant shall provide a written adequate justification and evidence satisfactory to the Client together with the substitution request. In such case, a substitute Key Expert shall have equal or better qualifications and experience than those of the originally proposed Key Expert. The technical

evaluation score, however, will remain to be based on the evaluation of the CV of the original Key Expert.

12.8 If the Consultant fails to provide a substitute Key Expert with equal or better qualifications, or if the provided reasons for the replacement or justification are unacceptable to the Client, such Proposal will be rejected with the prior Bank's no objection.

c. Sub-Contracting

12.9 The Consultant shall not subcontract the whole of the Services.

13. Clarification and Amendment of RFP

13.1 The Consultant may request a clarification of any part of the RFP during the period indicated in the **Data Sheet** before the Proposals' submission deadline. Any request for clarification must be sent in writing, or by standard electronic means, to the Client's address indicated in the **Data Sheet**. The Client will respond in writing, or by standard electronic means, and will send written copies of the response (including an explanation of the query but without identifying its source) to all Consultants. Should the Client deem it necessary to amend the RFP as a result of a clarification, it shall do so following the procedure described below:

13.1.1 At any time before the proposal submission deadline, the Client may amend the RFP by issuing an amendment in writing or by standard electronic means. The amendment shall be sent to all Consultants and will be binding on them. The Consultants shall acknowledge receipt of all amendments in writing.

13.1.2 If the amendment is substantial, the Client may extend the proposal submission deadline to give the Consultants reasonable time to take an amendment into account in their Proposals.

13.2 The Consultant may submit a modified Proposal or a modification to any part of it at any time prior to the proposal submission deadline. No modifications to the Technical or Financial Proposal shall be accepted after the deadline.

14. Preparation of Proposals Specific Considerations

14.1 While preparing the Proposal, the Consultant must give particular attention to the following:

14.1.1 If a Consultant considers that it may enhance its expertise for the assignment by associating with other consultants in the form of a Joint Venture or as Sub-consultants, it may do so.

14.1.2 The Client may indicate in the **Data Sheet** the estimated Key Experts' time input (expressed in person-month) or the Client's estimated total cost of the assignment, but not both. This estimate is indicative and the Proposal shall be based on the Consultant's own estimates for the same.

14.1.3 If stated in the **Data Sheet**, the Consultant shall include in its Proposal at least the same time input (in the same unit as indicated in the **Data Sheet**) of Key Experts, failing which the Financial Proposal will be adjusted for the purpose of comparison of proposals and decision for award in accordance with the procedure in the **Data Sheet**.

14.1.4 For assignments under the Fixed-Budget selection method, the estimated Key Experts' time input is not disclosed. Total available budget, with an indication whether it is inclusive or exclusive of taxes, is given in the **Data Sheet**, and the Financial Proposal shall not exceed this budget.

15. Technical Proposal Format and Content

15.1 The Technical Proposal shall be prepared using the Standard Forms provided in Section 3 of the RFP and shall comprise the documents listed in the **Data Sheet**. The Technical Proposal shall not include any financial information. A Technical Proposal containing material financial information shall be declared non-responsive.

15.1.1 Consultant shall not propose alternative Key Experts. Only one CV shall be submitted for each Key Expert position. Failure to comply with this requirement will make the Proposal non-responsive.

15.2 Depending on the nature of the assignment, the Consultant is required to submit a Full Technical Proposal (FTP), or a Simplified Technical Proposal (STP) as indicated in the **Data Sheet** and using the Standard Forms provided in Section 3 of the RFP.

16. Financial

16.1 The Financial Proposal shall be prepared using the Standard Forms provided in Section 4 of the RFP. It shall list all costs associated with the assignment, including (a)

Proposal	remuneration for Key Experts and Non-Key Experts, (b) reimbursable expenses indicated in the Data Sheet .
a. Price Adjustment	16.2 For assignments with a duration exceeding 18 months, a price adjustment provision for foreign and/or local inflation for remuneration rates applies if so stated in the Data Sheet .
b. Taxes	16.3 The Consultant and its Sub-consultants and Experts are responsible for meeting all tax liabilities arising out of the Contract unless stated otherwise in the Data Sheet . Information on taxes in the Client's country is provided in the Data Sheet .
c. Currency of Proposal	16.4 The Consultant may express the price for its Services in the currency or currencies as stated in the Data Sheet . If indicated in the Data Sheet , the portion of the price representing local cost shall be stated in the national currency.
d. Currency of Payment	16.5 Payment under the Contract shall be made in the currency or currencies in which the payment is requested in the Proposal.

C. Submission, Opening and Evaluation

17. Submission, Sealing, and Marking of Proposals	<p>17.1 The Consultant shall submit a signed and complete Proposal comprising the documents and forms in accordance with ITC 10 (Documents Comprising Proposal). Consultants shall mark as "CONFIDENTIAL" information in their Proposals which is confidential to their business. This may include proprietary information, trade secrets or commercial or financially sensitive information. The submission can be done by mail or by hand. If specified in the Data Sheet, the Consultant has the option of submitting its Proposals electronically.</p> <p>17.2 An authorized representative of the Consultant shall sign the original submission letters in the required format for both the Technical Proposal and, if applicable, the Financial Proposal and shall initial all pages of both. - 18. Confidentiality**
- 18.1 From the time the Proposals are opened to the time the Contract is awarded, the Consultant should not contact the Client on any matter related to its Technical and/or Financial Proposal. Information relating to the evaluation of Proposals and award recommendations shall not be disclosed to the Consultants who submitted the Proposals or to any other party not officially concerned with the process, until the Notification of Intention to Award the Contract. - 20.2 The Consultant is not permitted to alter or modify its Proposal in any way after the proposal submission deadline except as permitted under ITC 12.7. While evaluating the Proposals, the Client will conduct the evaluation solely on the basis of the submitted Technical and Financial Proposals.
- 21. Evaluation of Technical Proposals**
- 21.1 The Client's evaluation committee shall evaluate the Technical Proposals on the basis of their responsiveness to the Terms of Reference and the RFP, applying the evaluation criteria, sub-criteria, and point system specified in the **Data Sheet**. Each responsive Proposal will be given a technical score. A Proposal shall be rejected at this stage if it does not respond to important aspects of the RFP or if it fails to achieve the minimum technical score indicated in the **Data Sheet**.
- 22. Financial Proposals for QBS**
- 22.1 Following the ranking of the Technical Proposals, when the selection is based on quality only (QBS), the top-ranked Consultant is invited to negotiate the Contract.
- 22.2 If Financial Proposals were invited together with the Technical Proposals, only the Financial Proposal of the technically top-ranked Consultant is opened by the Client's evaluation committee. All other Financial Proposals are returned unopened after the Contract negotiations are successfully concluded and the Contract is signed.
- 23. Public Opening of Financial Proposals (for QCBS, FBS, and LCS methods)**
- 23.1 After the technical evaluation is completed and the Bank has issued its no objection (if applicable), the Client shall notify those Consultants whose Proposals were considered non-responsive to the RFP and TOR or did not meet the minimum qualifying technical score, advising them the following:
- (i) their Proposal was not responsive to the RFP and TOR or did not meet the minimum qualifying technical score;
 - (ii) provide information relating to the Consultant's overall technical score, as well as scores obtained for each criterion and sub-criterion;
 - (iii) their Financial Proposals will be returned unopened after completing the selection process and Contract signing; and

- (iv) notify them of the date, time and location of the public opening of the Financial Proposals and invite them to attend.

23.2 The Client shall simultaneously notify in writing those Consultants whose Proposals were considered responsive to the RFP and TOR, and that have achieved the minimum qualifying technical score, advising them the following:

- (i) their Proposal was responsive to the RFP and TOR and met the minimum qualifying technical score;
- (ii) provide information relating to the Consultant's overall technical score, as well as scores obtained for each criterion and sub-criterion;
- (iii) their Financial Proposal will be opened at the public opening of Financial Proposals; and
- (iv) notify them of the date, time and location of the public opening and invite them for the opening of the Financial Proposals.

23.3 The opening date should allow the Consultants sufficient time to make arrangements for attending the opening and shall be no less than seven (7) Business Days from the date of notification of the results of the technical evaluation, described in ITC 23.1 and 23.2.

23.4 The Consultant's attendance at the opening of the Financial Proposals (in person, or online if such option is indicated in the **Data Sheet**) is optional and is at the Consultant's choice.

23.5 The Financial Proposals shall be opened publicly by the Client's evaluation committee in the presence of the representatives of the Consultants and anyone else who chooses to attend. Any interested party who wishes to attend this public opening should contact the client as indicated in the **Data Sheet**. Alternatively, a notice of the public opening of Financial Proposals may be published on the Client's website, if available. At the opening, the names of the Consultants, and the overall technical scores, including the break-down by criterion, shall be read aloud. The Financial Proposals will then be inspected to confirm that they have remained sealed and unopened. These Financial Proposals shall be then opened, and the total prices read aloud and recorded. Copies of the record shall be sent to all Consultants who submitted Proposals and to the Bank.

24. Correction of Errors 24.1 Activities and items described in the Technical Proposal but not priced in the Financial Proposal, shall be assumed to be included in the prices of other activities or items, and no corrections are made to the Financial Proposal.

a. Time-Based Contracts 24.1.1 If a Time-Based contract form is included in the RFP, the Client's evaluation committee will (a) correct any computational or arithmetical errors, and (b) adjust the prices if they fail to reflect all inputs included for the respective activities or items included in the Technical Proposal. In case of discrepancy between (i) a partial amount (sub-total) and the total amount, or (ii) between the amount derived by multiplication of unit price with quantity and the total price, or (iii) between words and figures, the former will prevail. In case of discrepancy between the Technical and Financial Proposals in indicating quantities of input, the Technical Proposal prevails and the Client's evaluation committee shall correct the quantification indicated in the Financial Proposal so as to make it consistent with that indicated in the Technical Proposal, apply the relevant unit price included in the Financial Proposal to the corrected quantity, and correct the total Proposal cost.

b. - 27.3 The Client will select the Consultant with the Most Advantageous Proposal, which is the highest-ranked Technical Proposal that does not exceed the budget indicated in the RFP, and invite such Consultant to negotiate the Contract.

D. Negotiations and Award

- 28. Negotiations** 28.1 The negotiations will be held at the date and address indicated in the Data Sheet with the Consultant's representative(s) who must have written power of attorney to negotiate and sign a Contract on behalf of the Consultant.
- 28.2 The Client shall prepare minutes of negotiations that are signed by the Client and the Consultant's authorized representative.
- a. Availability of Key Experts** 28.3 The invited Consultant shall confirm the availability of all Key Experts included in the Proposal as a pre-requisite to the negotiations, or, if applicable, a replacement in accordance with ITC 12. Failure to confirm the Key Experts' availability may result in the rejection of the Consultant's Proposal and the Client proceeding to negotiate the Contract with the next-ranked Consultant.
- 28.4 Notwithstanding the above, the substitution of Key Experts at the negotiations may be considered if due solely to circumstances outside the reasonable control of and not foreseeable by the Consultant, including but not limited to death or medical incapacity. In such case, the Consultant shall offer a substitute Key Expert within the period of time specified in the letter of invitation to negotiate the Contract, who shall have equivalent or better qualifications and experience than the original candidate.
- b. Technical Negotiations** 28.5 The negotiations include discussions of the Terms of Reference (TORs), the proposed methodology, the Client's inputs, the special conditions of the Contract, and finalizing the "Description of Services" part of the Contract. These discussions shall not substantially alter the original scope of services under the TOR or the terms of the contract, lest the quality of the final product, its price, or the relevance of the initial evaluation be affected.

30.1 After completing the negotiations, the Client shall obtain the Bank's no objection to the negotiated draft Contract, if applicable; sign the Contract; publish the award information as per the instructions in the Data Sheet; and promptly notify the other Consultants.

30.2 The Consultant is expected to commence the assignment on the date and at the location specified in the **Data Sheet**.

 - ii. "fraudulent practice" is any act or omission, including misrepresentation, that knowingly or recklessly misleads, or attempts to mislead, a party to obtain financial or other benefit or to avoid an obligation;
 - iii. "collusive practice" is an arrangement between two or more parties designed to achieve an improper purpose, including to influence improperly the actions of another party;
 - iv. "coercive practice" is impairing or harming, or threatening to impair or harm, directly or indirectly, any party or the property of the party to influence improperly the actions of a party;
 - v. "obstructive practice" is:
 - (a) deliberately destroying, falsifying, altering, or concealing of evidence material to the investigation or making false statements to investigators in order to materially impede a Bank investigation into allegations of a corrupt, fraudulent, coercive, or collusive practice; and/or threatening, harassing, or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; or
 - (b) acts intended to materially impede the exercise of the Bank's inspection and audit rights provided for under paragraph 2.2 e. below.
- b. Rejects a proposal for award if the Bank determines that the firm or individual recommended for award, any of its personnel, or its agents, or its sub-consultants, sub-contractors, service providers, suppliers and/ or their employees, has, directly or indirectly, engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices in competing for the contract in question;
- c. In addition to the legal remedies set out in the relevant Legal Agreement, may take other appropriate actions, including declaring misprocurement, if the Bank determines at any time that representatives of the Borrower or of a recipient of any part of the proceeds of the loan engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices during the procurement process, selection and/or execution of the contract in question, without the Borrower having taken timely and appropriate action satisfactory to the Bank to address such practices when they occur, including by failing to inform the Bank in a timely manner at the time they knew of the practices;
- d. Pursuant to the Bank's Anti- Corruption Guidelines and in accordance with the Bank's prevailing sanctions policies and procedures, may sanction a firm or individual, either indefinitely or for a stated period of time, including by publicly declaring such firm or individual ineligible (i) to be awarded or

otherwise benefit from a Bank-financed contract, financially or in any other manner;¹ (ii) to be a nominated² sub-contractor, consultant, manufacturer or supplier, or service provider of an otherwise eligible firm being awarded a Bank-financed contract; and (iii) to receive the proceeds of any loan made by the Bank or otherwise to participate further in the preparation or implementation of any Bank-financed project;

- e. Requires that a clause be included in bidding/request for proposals documents and in contracts financed by a Bank loan, requiring (i) bidders (applicants/proposers), consultants, contractors, and suppliers, and their sub-contractors, sub-consultants, service providers, suppliers, agents personnel, permit the Bank to inspect³ all accounts, records and other documents relating to the procurement process, selection and/or contract execution, and to have them audited by auditors appointed by the Bank.

¹ For the avoidance of doubt, a sanctioned party's ineligibility to be awarded a contract shall include, without limitation, (i) applying for pre-qualification, expressing interest in a consultancy, and bidding, either directly or as a nominated sub-contractor, nominated consultant, nominated manufacturer or supplier, or nominated service provider, in respect of such contract, and (ii) entering into an addendum or amendment introducing a material modification to any existing contract.

² A nominated sub-contractor, nominated consultant, nominated manufacturer or supplier, or nominated service provider (different names are used depending on the particular bidding document) is one which has been: (i) included by the bidder in its pre-qualification application or bid because it brings specific and critical experience and know-how that allow the bidder to meet the qualification requirements for the particular bid; or (ii) appointed by the Borrower.

³ Inspections in this context usually are investigative (i.e., forensic) in nature. They involve fact-finding activities undertaken by the Bank or persons appointed by the Bank to address specific matters related to investigations/audits, such as evaluating the veracity of an allegation of possible Fraud and Corruption, through the appropriate mechanisms. 2. The Project Development Objective (PDO) of APART is to – “add value and improve resilience of selected agriculture value chains, focusing on smallholder farmers and agro-entrepreneurs and to advance Assam’s COVID-19 response”.
3. There are four components of the project with different sub components. The **first component-A** is Enabling Agri. Enterprise Development, the **second component-B** is Facilitating Agro Cluster Development, the third **component-C** is Fostering Market Led Production and Resilience Enhancement and the fourth **component-D** is Project Management, Monitoring and Learning.
4. The U.N. General Assembly recently adopted a resolution, sponsored by India and supported by more than 70 countries, declaring 2023 as the International Year of Millets. The resolution is intended to increase public awareness on the health benefits of millets and their suitability for cultivation under tough conditions marked by climate change. The Govt of Assam in a bid to observe 2023 as the year of millets has set up the Assam Millets Mission (AMM) for a period of seven years. Setting up of Assam Millets Mission was approved by the State Cabinet in May 2023. The activities in first two years of the Mission will be funded under APART. A part of the activities in the third year will also be funded under APART. From third year onwards the funding support to the Mission will be from State Govt as well as Govt of India schemes.
5. **Component C** of APART i.e. *Fostering Market-led Production and Resilience Enhancement* aims to enable producers of the priority value chains, in the targeted clusters, to take advantage of the rapidly changing market demand, and enhance resilience of agriculture production systems for increasing production and managing risks associated with climate change. This would be achieved by: **(i)** improvements in production technologies and management practices through climate resilient solutions; **(ii)** facilitation of collective-action by producers by supporting the establishment of farmer producer organizations (FPOs);

(iii) improving value realization at the farm level through improved cleaning, grading and packing of produce through common service centers (CSCs) managed by FPOs; (iv) facilitation of market linkages through market information and intelligence; and (v) facilitating access to a broad set of financial services and their responsible use by producers.

6. **Sub-component C-1** of APART i.e. *Promoting climate resilient technologies and their adoption*, aims to support sustainable increase in production and productivity of the priority value chains, and promote the adoption of climate resilient solutions. This would be achieved by geographically targeted approach for the integrated development of these value chains and will make key investments in the production clusters of prioritized value chains.

7. Indicative activities to be taken up under AMM in the first two years include:

A. Market and nutrition supportive production

- a. Technology demonstrations
- b. Minikits distribution
- c. Seed production & distribution
- d. Farm machinery (need based)
- e. Cropping system demos with pulses & other crops

B. Post-harvest & value addition side aspects

- a. Post-harvest demonstrations on drying & quality preservation
- b. Small Storage Bins (SSBs)
- c. Nutritious millet products development fund

C. Market linkages

- a. Buyer Seller Meets
- b. Product exhibitions

D. Ensuring better nutrition, healthy & disease free Assam through millets

- a. Distribution of millets based products in rural areas
 - i. Awareness creation
 - ii. Supply of millet based products in rural areas
- b. Millets in mid-day meal scheme (through education Deptt- SSA)
 - i. Awareness creation
 - ii. Supply and distribution in schools

8. Now the Project intends to engage the services of a **consultancy agency** to set up and manage the State Project Management Unit (SPMU) to be housed in the Directorate Agriculture for a period of two years or upto September 2024 whichever is earlier, as per the terms and conditions given hereunder. *Consulting agency with its technical resources (as explained in subsequent paragraphs) would be engaged in providing mentoring and handholding support to the implementing agencies of Govt of Assam in successful accomplishment of the activities under the AMM.*

(B) Objective & Scope of the Assignment

9. The key focus of the assignment is to set up and manage the State Project Management Unit (SPMU) with suitably experienced and qualified technical staff and provide technical handholding & mentoring support to the implementing agencies of Govt of Assam in smooth and timely carrying out of the activities under the Mission manner. It may also be noted that for technical support in some of the key activities like (i) introduction & scaling up of promising germplasm, nutritional profiling of millets, farm gate processing and value addition, training and capacity building (for development of Master Trainers including international trainings), new recipe development, harnessing the export market potential, the Project is in the process of onboarding the International Crops Research Institute for the Semi Arid Tropics (ICRISAT) and the Indian Council of Agricultural Research (ICAR)-Indian Institute of Millets Research (IIMR).

(C) Activities/ Interventions to be undertaken in (AMM)

10. Market and Nutrition Supportive Production

- a. **Technology demonstrations:** Market led, climate resilient production demonstrations of millets will be taken up in the 15 priority districts, as per the approved Annual Work Plan (AWP) of the Operational Project Implementation Unit (OPIU) Agriculture. At the district level, this activity will be implemented through District ATMA offices. The critical inputs including seeds for these demonstrations will be provided by the Project. Year-wise following number of demonstrations will be taken up:

- b. **Mini-kits distribution:** Mini-kits are a good way to ensure farmer to farmer spread of seeds. About two Kg seeds will be supplied to each individual beneficiary farmer to show the performance of the crop and variety. This helps to spread the information on performance of variety through word of mouth. Following number of mini-kit demonstrations will be taken up annually under the Mission:

- c. **Seed production and distribution:** Millets seeds production will be taken up with progressive farmers and FPCs. The long term objective of seed production initiative is to make the State self-sufficient in selected millet crop seeds. For seed production, technical support of Assam Agricultural University (AAU) will be obtained. The seed certification will be done by Assam Seed and Organic Certification Agency (ASOCA). Distribution of seeds to farmers will be done through District Agriculture Offices and KVVKs etc. Testing & trials of new promising varieties for future area expansion may be done with *Krishi*

Vigyan Kendras (KKVs) and Research Stations of AAU. The following quantities of seeds is planned to be produced:

- d. **Cropping system demos with pulses & other crops:** In a quest to diversify the Assam's Agriculture from rice-based cropping systems, it is proposed that 10% of technology demos will be taken up with cropping systems approach involving pulses. Most of the pulses are low water requiring crops, so are millets. While pulses contribute to protein requirement in the diet, millets contribute to an overall healthy and nutritious diet. Cropping systems approach ensures better acceptance of the field interventions among the farmers. With the advent of short duration varieties, it would be possible to fit three crops instead of two within a year, thus providing better realizations to farmers. Further this can help transformation of Assam agricultural systems by shifting the focus to high value and high nutrition produce including millets. Possibility of conducting some of these demos under organic certification will be explored. The following demonstrations will be taken up in cropping systems approach:

11. Post Harvest Management, Value Addition, Processing & Recipe Development

- a. **Post harvest demonstrations on drying & quality preservation:** Most of the millets are dryland crops and are adept to low moisture conditions. However, Assam being a highly humid state, criticality of proper drying in case of millets cannot be ignored. One of the oldest methods used for preservation of millets and other food products to increase their shelf life is drying. Scientific methods of drying will be demonstrated to the millet farmers and other value chain players. The following number of demonstrations on drying and quality preservation will be taken up:

- b. **Small Storage Bins (SSBs):** Looking at the fact that majority of farmers in Assam are smallholders it is proposed that Small Storage Bins (SSBs) will be provided to FPCs/ Farmer Groups. The major advantage of storage bins is that these are portable and can be transported from one place to other. The Consulting Agency shall provide its technical support in terms of specifications, long list of suppliers, preparation of the tender document and timely procurement and supply of these machines to beneficiary farmers in a timely manner. The following numbers will be procured:

- c. **Nutritious millet products and recipe development fund:** A number of nutritious products can be developed from millets. These include flour, biscuits, cookies etc. Flour can be used for making many other products. Biscuits and cookies which are used as snack items are usually consumed with tea/ coffee. Other products include bread, bun, extruded snacks, flakes etc. Pasta, vermicelli, cake etc. are the millet products which are popular among children & youngsters and are highly relished by them. Baby food is another product segment in which millets find application. Millets energy bar can be used to address the problem of malnutrition among the poor pre-school and school going children. However, while formulating such products and recipe development, local food habits and availability of other ingredients

need to be taken into consideration. A fund of Rs 250 lakhs has been parked in the 2nd year of the Mission for development of nutritious products development. The Consultant shall help the Project in formulation of multiple products for women, children and general population, their testing, trials, packing, labelling in collaboration with technical institutions and laboratories etc.

12. Market linkages:

- a. **Buyer Seller Meets (BSMs):** The objective of Buyer Seller Meets (BSMs) is to bring the buyers and sellers of agri commodities on the same platform so as to understand each other's requirements in terms of quantity, quality, time of availability and price of agro commodities. Finally the BSM should lead to business linkages and ultimately smooth closing of maximum number and value of deals between the buyers and sellers. BSMs will be organized at District level and would target potential buyers, FPC members farmers, logistics service providers, packaging solution providers, bankers and other stakeholders. **15 BSMs will be organized in the second year of the Mission.**
- b. **Product exhibitions:** Product exhibitions are a good way of showcasing the creations of farmers and entrepreneurs in terms of products prepared through primary and secondary processing. Product exhibitions will not only show case and demonstrate the diversity food products prepared from millets but will also act as a platform for exchange of information on various aspects of millets value chain among the stakeholders and also help negotiate trade deals between FPCs and buyers. Apart from buyers and support service providers, such exhibitions will be open for general public (consumers) as well wherein direct feedback of consumers may be obtained on the products as well the products can be retailed out to them. Cooking shows, taste reviews and organoleptic events will also be part of such exhibitions. **10 product exhibitions will be organized in the second year of the Mission.**

13. Ensuring better nutrition, healthy and disease free Assam through millets

- a. **Distribution of millets based products in rural areas:** This will be ensured by way of awareness creation and supply of millets based products. Moreover, Awareness will be created about the scheme as a whole and rural mobile distribution initiative in particular in various ways. The following activities will be carried out under product distribution in rural areas:

- b. **Millets in PM POSHAN through Department of Elementary Education/ Sarba Siksha Abhiyan:** Awareness will be created about the scheme in the schools through training of students & staff and so also cooks and helpers, distribution of literature, showing small videos including stories on health benefits of millets. Apart from this, wall paintings in schools will also be made on importance of millets in children's diets. Agreements will be made with school administration to have a half an hour session with the students just before mid-day meal, on importance of millets, their nutrition and health benefits, role in balanced diet etc. In addition, benefits of millets consumption will be discussed in school assemblies. Furthermore, hoardings on nutritional benefits of millets may be installed in the prominent places of District and Block Offices. This will be done in collaboration with *Sarva Siksha Abhiyan* under the Elementary Education Department which implements the Mid Day Meal (MDM) scheme (now PM POSHAN).

As hot cooked meals only are to supplied to school children (Class 1 to 8), under PM POSHAN, millet raw materials for preparing these meals will be supplied to schools by FPCs locally (within district) ensuring that the products comply all quality, hygiene and nutritional standards and specifications as prescribed. Sample testing and reporting for the products to be supplied will be done beforehand. In order to economise on the logistics cost, products as per pre-defined menu with sufficient choice will be supplied to schools from the nearby FPCs. Initially, since the quantities available may be low, supply to schools may be done once in a week or 15 days (weekly or fortnightly millets based menu) or pilot scale supplies may be done in few of the districts. In such a scenario, focus may be given to seven aspirational districts of Assam viz. Hailakandi, Dhubri, Darrang, Barpeta, Baksa, Udalguri and Goalpara including one extra high burden district (HBD) as per NFHS-4 (2015-16) of the state viz. Cachar. Till the FPCs & CSCs are

established, raw products may be aggregated from the individual grower farmers, processed at locally available facilities in the private sector and made available to the schools. The following activities will be taken up:

- c. **Millet nutrition in expecting & lactating women and children (in collaboration with POSHAN Abhiyan):** Nutrition camps will be organized in rural and semi urban areas for women (particularly adolescent, expecting and lactating) and children on importance of healthy and balanced diets, benefits of inclusion of millets in their diets. This can be accomplished through Focus Group Discussions (FGDs) in the villages and small towns as well as distribution of literature, showing small videos including stories on health benefits of millets etc. ICDS Districts shall be given preference for these activities. Under the *Poshan Abhiyan*, nutritious food products are supplied to pre-school children (6 months to 6 years) in *Anganwadis* and at households. The scheme also covers adolescent girls, pregnant women and lactating mothers. As the amount of nutrition to be provided through the food products has already been laid down under the scheme, the products to be supplied from the Assam Millets Mission (AMM) will be complying to these specifications. Sample test reporting shall be done before supply of products. The following activities will be taken up:

14. Training and capacity building, conduct of events & miscellaneous

- a. **Exposure visits:** Exposure visits will be arranged to institutes/ organizations of national and international importance like Indian Institute of Millets Research (IIMR), Hyderabad and International Crop Research Institute for the Semi Arid Tropics (ICRISAT), Hyderabad and its branch centres in other countries. In due course of time, other similar institutes/ organizations may be targeted for exposure visits. The following exposure visits will be taken up (number of persons shown are tentative and can vary in actual):

- b. **Trainings:** Specialized trainings will be conducted for Govt and Project staff to develop them as Master Trainers. Few BODs of millets FPCs may also be included in some of these trainings. For each training program, the content, structure & sessions schedule along with profile of resource persons shall be submitted in advance by the Consultant to the Client. Arrangement of venue with training aids like LCD, Projector etc, lunch, tea & snacks, photography etc shall be made by the Client. The training sessions would be interactive in nature involving active participation of trainees. It would be ensured that two way communication flow between the trainer and trainees is maintained during the training program sessions. The trainers/faculty members will extensively use role plays, management games, team exercises, group tasks etc. Field visits (costs to be borne by Client based on prior intimation) to nearby places may also be arranged in order to ensure live exposure. At the end of each training program, a feedback form will be circulated to the trainees which should be filled up by the trainees there itself and submitted back to the lead trainer before the closure of training. A copy of the feedback forms will be

shared with the Client. Filling of feedback forms online through mobile phone/tablet/laptop etc shall be preferred. A training completion certificate jointly signed by the Consulting Agency and the Client shall be provided to all the trainees who have attended all the sessions of a training program. The certificate would be provided at the end of training program. The format of training completion certificate shall be vetted by the Client in advance. In general the timings of the training would be 10 am to 5 pm, unless otherwise stated. There would be one hour lunch break around noon time. There would be two tea/coffee breaks of half an hour each, one during morning session and another during afternoon session. After each training, a brief training completion report would be submitted by the Consultant covering title of the training, topics covered, participant list, group photographs, major queries raised by the participants and general feedback. This report may be submitted within one week of completion of a particular training. To ensure effectiveness of trainings, the optimum batch size suggested is 25-30 trainees. - c. **Millets and pulses business conclave:** This will be a mega event conducted at State level in the second year which will bring together the stakeholders in the millets value chain including input suppliers, FPCs, traders, processors, policy makers, administrators both from the public and private sector to enhance the performance of the millets value chain. An exhibition on the sidelines will also be arranged to showcase the millet products from the initiative. Relevant supply tie-ups between FPCs and bulk buyers/processors will also be forged during the business conclave. The cost of organization of the conclave will be borne by the Client while the *mobilization of stakeholders, planning and actual conduct of the event shall be the responsibility of the Consulting Agency.*
- d. **Millets Knowledge Bank (MKB):** Millets Knowledge Bank (MKB) will be an integrated platform for all knowledge resources on millets. MKB would showcase millets production techniques, cultivation technologies, best farming practices, processing, value addition, recipes, markets and marketing in millets as a pool of knowledge from research findings, learning and media resources, and in-country projects etc. Sufficient number of Project and Govt staff including those from Assam Agricultural University (AAU) shall be trained on MKB to ensure that it is maintained and updated even after the exit of the Consultant.
15. **Exit strategy and knowledge repository on Agricultural Policies:** Towards the closure of the assignment (**last six months**), the Consulting Agency shall prepare and submit an implementable exit strategy which ensures the spontaneity of the knowledge transfer to the Project as well as the concerned Departments of Govt of Assam & AAU. The Consulting Agency shall also support the Client in setting up a sustainable mechanism for continuous updating of the knowledge materials developed during the assignment. For this, the needed training and capacity building of the Project and Departmental staff shall be carried out by **Consulting Agency**. The Agency will be required to submit a detailed program of exit strategy before completion of one year which will be vetted by the Client. This activity **shall be completed before the submission of final/end term report.**

(D) Reports to be submitted

16. **Inception Report (IR) & Assignment kick off meeting:** The Consulting Agency will submit an inception report *within one month* of contract effectiveness. The inception report will comprise of detailed work plan, milestones, methodology and resources to be mobilized to accomplish the assignment. It would also cover detailed mobilization arrangements, complete description of all activities required for the key deliverables, complete Work Plan to ensure timely start-up and on-time completion of the tasks assigned. The Consultant would also organize an assignment kick off meeting with involvement of all possible stakeholders associated with the assignment i.e. including Project staff, Govt Departments staff at State and District level in presence of Consultant's team. During the kick off meeting, activities in the assignment will be discussed in detail along with roles, responsibilities, assignment methodology and processes to be followed. Proceedings of the kick off meeting may be included in the Inception Report. First payment will be made based on the acceptance of Inception Report.
17. **Six-Monthly reports:** At the end of every six months from contract effectiveness, a report highlighting the technical support activities carried out during the period as per Log-frame to be submitted within 30 office working days from the completion of every six months. The payment requests from Consulting Agency are to be based on the Payment Schedule against deliverables which will be a part of the contract agreement. Acceptance of six monthly reports will be the basis of payment for technical support activities performed by the Consulting Agency during the reporting period.
18. **Mid-Term report:** to be submitted within 30 office working days from the completion of 12 months (one year) from contract effectiveness and should focus on **(a)** implementation processes and recommend mid-term corrections, if any, required to achieve the prescribed targets, adjustments in the assignment design **(b)** implementation arrangements to overcome identified bottlenecks and **(c)** socio-economic analysis, in addition to overall review of the progress of assignment implementation under different activities and sub-activities, as per the approved action plan covering all deliverables (technical and physical) with suggestions for improvements.
19. **Final/ End-Term report** will have to be submitted by the Consultant at *least 45 days before the closure of the consultancy assignment*. The report shall include a comprehensive overall assessment of the implementation, impact of the activities on the overall agricultural scenario of the State.

(E) Reporting requirements:

20. Consulting Agency will submit the reports/documents, covering the activities performed during the reporting period, to SPD, ARIAS Society in both MS - Word and PDF versions along with raw data excels etc to assess the progress against the targets. All the reports will be in English language. All reports shall be first submitted in draft form for comments/ observations/ views of the Client. The comments/ views/ observations of the Client shall be addressed and final reports will be submitted accordingly. All final six monthly reports & inception report shall be accompanied by an invoice as per the contract agreement, raised in favour of SPD, ARIAS Society. The Consulting Agency may be required to make presentation(s) on the submitted draft/final reports on date, time and venue as per convenience of the Client.

21. Deliverables and payment schedule

Consulting Agency shall have to provide the information on deliverable wise payments in the following format with the condition that total payment marked for first year should not be more than 50% of the assignment value and total payment for first semester should not be more than 25% of the assignment value. Similarly total payments in the 3rd semester of the assignments shall not be more than 25% of the assignment value. It may be noted that the finger millets demonstrations for the first year have already been put up (sowing done around August 2022 and transplanting in September 2022). Consulting Agency should plan its resources accordingly & which should be reflected in their proposal.
