**For hiring of Specialists for 'Business Process Re-engineering & IT' and for 'ICT Infrastructure'**

The Government of Assam (GoA) through the Government of India has applied for a credit of US \$39.2 million from the World Bank (W.B.) for implementation of the ACCSDP and a Project Preparatory Facility (PPF) of US\$ 2 million has already been approved by the W.B. The ACCSDP aims to strengthen the electronic delivery of citizen centric services under the Assam RTPS Act, 2012 for augmenting citizen's access to the targeted RTPS services. ARIAS Society, the agency responsible for implementation of the project, intends to hire **two Specialists**, one for **Business Process Re-engineering & IT** related activities and another for **ICT Infrastructure** related activities of the ACCSDP.

The State Project Director (SPD), ARIASS now invites applications from the eligible candidates for the two contractual positions of '**Business Process Re-engineering & IT Specialist**' and '**ICT Infrastructure Specialist**' in the ARIASS. **However, candidates who have earlier applied against REOI No. ARIASS/CCSDP/19/2015/54 dated 13<sup>th</sup> January 2016 for the positions of Senior Consultants for 'Electronic Services Delivery' and for 'ICT Infrastructure' need not apply.**

The draft Terms of Reference (TOR) for the two positions are given in the website of the ARIAS Society viz. <http://www.arias.in>. Depending on the qualifications, experience, competencies, etc. of the candidate, the consolidated yearly remuneration will be fixed between the range of **Rs.18.00 lakh to Rs.25.80 lakh** per year, including performance linked incentive, and others as indicated in the TOR. The minimum required qualifications and experience in-short are given below. However, detailed qualification & experience shall be as given in the draft TOR given in the website of ARIASS:

ICT Infrastructure Specialist	<p>Post Graduate in Electronics/Computer Science/IT or MCA/MSc. in Computer Science/Information Systems <b>with specialization in Information Technology</b> preferably along with MBA/PGDBM; Atleast <b>11 to 15</b> years of experience in managing ICT infrastructure in public agencies at managerial/ leadership position;</p> <p>However, Graduates (BE/B.Tech etc.) in Electronics/Computer Science with specialization in Information Technology and with experience of over <b>15</b> years in managing ICT infrastructure in public agencies at managerial/ leadership position may also be considered.</p> <p>In case sufficient candidates meeting the above cited criterion are not available, Graduates/Post graduates (BE/B.Tech etc.) in Electronics/Computer Science/ Information Technology having experience of over <b>07</b> years in managing ICT infrastructure in public agencies at managerial/ leadership position may also be considered, but they will be offered Mid-level consultant position at a lesser remuneration/CTP as indicated in TOR.</p>

**Candidates not meeting the above cited Qualifications & Experience need not apply.**
