- 1. The Government of Assam through the Government of India (hereinafter called 'Borrower") has received financing from the International Bank for Reconstruction and Development (IBRD) in the form of a "loan" (hereinafter called "loan") towards the cost of **APART. The ARIAS Society**, an implementing agency of the Client intends to apply a portion of the proceeds of this loan to eligible payments under the contract for which this Request for Proposals (RFP) is issued. Payments by the Bank will be made only at the request of the ARIAS Society and upon approval by the Bank, and will be subject, in all respects, to the terms and conditions of the financing agreement. The financing agreement prohibits a withdrawal from the loan account for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import, to the knowledge of the Bank, is prohibited by a decision of the United Nations Security council taken under Chapter VII of the Charter of the United Nations. No party other than the Client shall derive any rights from the financing agreement or have any claims to the proceeds of the loan.
- The Client now invites proposals to provide the following consulting services (hereinafter called "Services"): Hiring of Consulting Services for "Revival of Assam State Agricultural Marketing Board under APART". More details on the Services are provided in the Terms of Reference (Section 7).
- 3. A firm will be selected under **Quality and Cost Based Selection (QCBS)** procedures and in a **Full Technical Proposal (FTP)** format as described in this RFP, in accordance with the policies of the Bank detailed in the Bank's "Regulations for IPF Borrowers" July 2016 (" Procurement Regulations") which can be found at the following website: <u>www.worldbank.org/procure</u>.

Section 2. Instructions to Consultants and Data Sheet

Instructions to Consultants

A. General Provisions

- 1. Definitions
 - **(a)** "Affiliate(s)" means an individual or an entity that directly or indirectly controls, is controlled by, or is under common control with the Consultant.
 - (b) "Applicable Law" means the laws and any other instruments having the force of law in the Client's country, or in such other country as may be specified in the **Data Sheet**, as they may be issued and in force from time to time.
 - (c) "Bank" means the International Bank for Reconstruction and Development (IBRD) or the International Development Association (IDA).
 - (d) "Borrower" means the Government, Government agency or other entity that signs the *[loan/financing/grant¹]* agreement with the Bank.
 - (e) "Client" means the implementing agency that signs the Contract for the Services with the selected Consultant.
 - (f) "Consultant" means a legally-established professional consulting firm or an entity that may provide or provides the Services to the Client under the Contract.
 - (g) "Contract" means a legally binding written agreement signed between the Client and the Consultant and includes all the attached documents listed in its Clause 1 (the General Conditions of Contract (GCC), the Special Conditions of Contract (SCC), and the Appendices).
 - (h) "Data Sheet" means an integral part of the Instructions to Consultants (ITC) Section 2 that is used to reflect specific country and assignment conditions to supplement, but not to over-write, the provisions of the ITC.
 - (i) "Day" means a calendar day, unless otherwise specified as "Business Day". A Business Day is any day that is an official working day of the Borrower. It excludes the Borrower's official public holidays.
 - (j) "Experts" means, collectively, Key Experts, Non-Key Experts, or any other personnel of the Consultant, Sub-consultant or Joint Venture member(s).
 - (k) "Government" means the government of the Client's country.
 - (l) "in writing" means communicated in written form (e.g. by mail, e-mail, fax, including, if specified in the Data Sheet, distributed or received through the electronic-procurement system used by the Client) with proof of receipt;
 - (m) "Joint Venture (JV)" means an association with or without a legal personality distinct from that of its members, of more than one Consultant where one member has the authority to conduct all business for and on behalf of any and all the members of the JV, and where the members of the JV are jointly and severally liable to the Client for the performance of the Contract.
 - (n) "Key Expert(s)" means an individual professional whose skills, qualifications, knowledge and experience are critical to the performance of the Services under the Contract and whose CV is taken into account in the technical evaluation of the Consultant's proposal.
 - (o) "ITC" (this Section 2 of the RFP) means the Instructions to Consultants that provides the Consultants with all information needed to prepare their Proposals.
 - (p) "Non-Key Expert(s)" means an individual professional provided by the Consultant or its Sub-consultant and who is assigned to perform the Services or any part thereof under the Contract and whose CVs are not evaluated individually.
 - (q) "Proposal" means the Technical Proposal and the Financial Proposal of the Consultant.
 - (r) "RFP" means the Request for Proposals to be prepared by the Client for the selection of

Consultants, based on the SPD - RFP.

- (s) "SPD - RFP" means the Standard Procurement Document -Request for Proposals, which must be used by the Client as the basis for the preparation of the RFP.
- "Services" means the work to be performed by the Consultant pursuant to the Contract. (t)
- "Sub-consultant" means an entity to whom the Consultant intends to subcontract any (u) part of the Services while the Consultant remains responsible to the Client during the whole performance of the Contract.
- "Terms of Reference (TORs)" (this Section 7 of the RFP) means the Terms of Reference (v) that explains the objectives, scope of work, activities, and tasks to be performed, respective responsibilities of the Client and the Consultant, and expected results and deliverables of the assignment.
- The Client named in the **Data Sheet** intends to select a Consultant from those listed in 2. **Introduction** 2.1 the Request for Proposals (RFP), in accordance with the method of selection specified in the Data Sheet.

2.2 The Consultants are invited to submit a Technical Proposal and a Financial Proposal, or a Technical Proposal only, as specified in the **Data Sheet**, for consulting services required for the assignment named in the **Data Sheet**. The Proposal will be the basis for negotiating and ultimately signing the Contract with the selected Consultant.

The Consultants should familiarize themselves with the local conditions and take 2.3 them into account in preparing their Proposals, including attending a pre-proposal conference if one is specified in the **Data Sheet**. Attending any such pre-proposal conference is optional and is at the Consultants' expense.

2.4 The Client will timely provide, at no cost to the Consultants, the inputs, relevant project data, and reports required for the preparation of the Consultant's Proposal as specified in the Data Sheet.

Conflict of The Consultant is required to provide professional, objective, and impartial advice, at 3. 31 all times holding the Client's interests paramount, strictly avoiding conflicts with other assignments or its own corporate interests, and acting without any consideration for future work.

> 3.2 The Consultant has an obligation to disclose to the Client any situation of actual or potential conflict that impacts its capacity to serve the best interest of its Client. Failure to disclose such situations may lead to the disqualification of the Consultant or the termination of its Contract and/or sanctions by the Bank.

- 3.2.1 Without limitation on the generality of the foregoing, and unless stated otherwise in the Data Sheet the Consultant shall not be hired under the circumstances set forth below:
- a. Conflicting Conflict between consulting activities and procurement of goods, works or (i) Activities non-consulting services: a firm that has been engaged by the Client to provide goods, works, or non-consulting services for a project, or any of its Affiliates, shall be disqualified from providing consulting services resulting from or directly related to those goods, works, or non-consulting services. Conversely, a firm hired to provide consulting services for the preparation or implementation of a project, or any of its Affiliates, shall be disqualified from subsequently providing goods or works or non-consulting services resulting from or directly related to the consulting services for such preparation or implementation.
- **b.** Conflicting (ii) Conflict among consulting assignments: a Consultant (including its Experts and Sub-consultants) or any of its Affiliates shall not be hired for any Assignments assignment that, by its nature, may be in conflict with another assignment of the Consultant for the same or for another Client.
- Relationship with the Client's staff: a Consultant (including its Experts and c. Conflicting (iii) **Relationships** Sub-consultants) that has a close business or family relationship with a professional staff of the Borrower (or of the Client, or of implementing agency, or of a recipient of a part of the Bank's financing) who are directly or indirectly involved in any part of (i) the preparation of the Terms of

Interest

Reference for the assignment, (ii) the selection process for the Contract, or (iii) the supervision of the Contract, may not be awarded a Contract, unless the conflict stemming from this relationship has been resolved in a manner acceptable to the Bank throughout the selection process and the execution of the Contract.

4. Unfair
 4.1 Fairness and transparency in the selection process require that the Consultants or their Affiliates competing for a specific assignment do not derive a competitive advantage from having provided consulting services related to the assignment in question. To that end, the Client shall indicate in the Data Sheet and make available to all Consultants together with this RFP all information that would in that respect give such Consultant any unfair competitive advantage over competing Consultants.

5. Fraud and 5.1 The Bank requires compliance with the Bank's Anti-Corruption Guidelines and its prevailing sanctions policies and procedures as set forth in the WBG's Sanctions Framework, as set forth in Section 6.

5.2 In further pursuance of this policy, Consultants shall permit and shall cause their agents (where declared or not), subcontractors, sub-consultants, service providers, suppliers, and their personnel, to permit the Bank to inspect all accounts, records and other documents relating to any shortlisting process, Proposal submission, and contract performance (in the case of award), and to have them audited by auditors appointed by the Bank.

6. Eligibility 6.1 The Bank permits consultants (individuals and firms, including Joint Ventures and their individual members) from all countries to offer consulting services for Bank-financed projects.

6.2 Furthermore, it is the Consultant's responsibility to ensure that itsExperts, joint venture members, Sub-consultants, agents (declared or not), sub-contractors, service providers, suppliers and/or their employees meet the eligibility requirements as established by the Bank in the Applicable ProcurementRegulations.

- 6.3 As an exception to the foregoing ITC 6.1 and ITC 6.2 above:
- **a. Sanctions** 6.3.1 A Consultant that has been sanctioned by the Bank, pursuant to the Bank's Anti-Corruption Guidelines and in accordance with its prevailing sanctions policies and procedures as set forth in the WBG's Sanctions Framework as described in Section VI, Fraud and Corruption, paragraph 2.2 d., shall be ineligible to be shortlisted for, submit proposals for, or be awarded a Bank-financed contract or benefit from a Bank-financed contract, financially or otherwise, during such period of time as the Bank shall have determined. The list of debarred firms and individuals is available at the electronic address specified **in the Data Sheet**.

b. Prohibitions 6.3.2 Firms and individuals of a country or goods manufactured in a country may be ineligible if so indicated in Section 5 (Eligible Countries) and:

- (a) as a matter of law or official regulations, the Borrower's country prohibits commercial relations with that country, provided that the Bank is satisfied that such exclusion does not preclude effective competition for the provision of Services required; or
- (b) by an act of compliance with a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations, the Borrower's Country prohibits any import of goods from that country or any payments to any country, person, or entity in that country.

c. Restrictions for
State-Owned6.3.3State-owned enterprises or institutions in the Borrower's country may be eligible to
compete and be awarded a contract only if they can establish, in a manner acceptable to the
Bank, that they: (i) are legally and financially autonomous, (ii) operate under commercial law,
and (iii) are not under supervision of the Client.

d. Restrictions for 6.3.4 Government officials and civil servants of the Borrower's country are not eligible to **Public Employees** be included as Experts, individuals, or members of a team of Experts in the Consultant's Proposal unless:

- (i) the services of the government official or civil servant are of a unique and exceptional nature, or their participation is critical to project implementation; and
- (ii) their hiring would not create a conflict of interest, including any conflict with

employment or other laws, regulations, or policies of the Borrower. e. Borrower 6.3.5 A firm that is under a sanction of debarment by the Borrower from being awarded a contract is eligible to participate in this procurement, unless the Bank, at the Borrower's Debarment request, is satisfied that the debarment; (a) relates to fraud or corruption, and (b) followed a judicial or administrative proceeding that afforded the firm adequate due process. **B.** Preparation of Proposals 7. Language exchanged between the Consultant and the Client, shall be written in the language(s) specified in the Data Sheet. **10.** Documents 10.1 The Proposal shall comprise the documents and forms listed in the **Data Sheet**. **Comprising the** 10.2 If specified in the Data Sheet, the Consultant shall include a statement of an Proposal undertaking of the Consultant to observe, in competing for and executing a contract, the Client country's laws against fraud and corruption (including bribery). 10.3 The Consultant shall furnish information on commissions, gratuities, and fees, if any, paid or to be paid to agents or any other party relating to this Proposal and, if awarded, Contract execution, as requested in the Financial Proposal submission form (Section 4). 11. Only One 111 The Consultant (including the individual members of any Joint Venture) shall submit Proposal only one Proposal, either in its own name or as part of a Joint Venture in another Proposal. If a Consultant, including any Joint Venture member, submits or participates in more than one proposal, all such proposals shall be disqualified and rejected. This does not, however, preclude Sub-consultant, or the Consultant's staff from participating as Key Experts and Non-Key Experts in more than one Proposal when circumstances justify and if stated in the **Data** Sheet. 12. Proposal The Data Sheet indicates the period during which the Consultant's Proposal must 12.1 Validity remain valid after the Proposal submission deadline. 12.2 During this period, the Consultant shall maintain its original Proposal without any change, including the availability of the Key Experts, the proposed rates and the total price. 12.3 If it is established that any Key Expert nominated in the Consultant's Proposal was not available at the time of Proposal submission or was included in the Proposal without his/her confirmation, such Proposal shall be disgualified and rejected for further evaluation, and may be subject to sanctions in accordance with ITC 5. a. Extension of 12.4 The Client will make its best effort to complete the negotiations and award the **Validity Period** contractwithin the proposal's validity period. However, should the need arise, the Client may request, in writing, all Consultants who submitted Proposals prior to the submission deadline to extend the Proposals' validity. 12.5 If the Consultant agrees to extend the validity of its Proposal, it shall be done without any change in the original Proposal and with the confirmation of the availability of the Key Experts, except as provided in ITC 12.7. 12.6 The Consultant has the right to refuse to extend the validity of its Proposal in which case such Proposal will not be further evaluated. **b. Substitution of** 12.7 If any of the Key Experts become unavailable for the extended validity period, the Consultant shall seek to substitute him withanother Key Expert. The Consultant shall provide a **Key Experts at** Validity written adequate justification and evidence satisfactory to the Client together with the substitution request. In such case, a substitute Key Expert shall have equal or better Extension qualifications and experience than those of the originally proposed Key Expert. The technical

evaluation score, however, will remain to be based on the evaluation of the CV of the original Kev Expert.

12.8 If the Consultant fails to provide a substitute Key Expert with equal or better qualifications, or if the provided reasons for the replacement or justification are unacceptable to the Client, such Proposal will be rejected with the prior Bank's no objection.

12.9 The Consultant shall not subcontract the whole of the Services.

Considerations

13. Clarification 13.1 The Consultant may request a clarification of any part of the RFP during the period indicated in the Data Sheet before the Proposals' submission deadline. Any request for and Amendment of RFP clarification must be sent in writing, or by standard electronic means, to the Client's address indicated in the Data Sheet. The Client will respond in writing, or by standard electronic means, and will send written copies of the response (including an explanation of the query but without identifying its source) to all Consultants. Should the Client deem it necessary to amend the RFP as a result of a clarification, it shall do so following the procedure described below:

- 13.1.1 At any time before the proposal submission deadline, the Client may amend the RFP by issuing an amendment in writing or by standard electronic means. The amendment shall be sent to all Consultants and will be binding on them. The Consultants shall acknowledge receipt of all amendments in writing.
- 13.1.2 If the amendment is substantial, the Client may extend the proposal submission deadline to give the Consultants reasonable time to take an amendment into account in their Proposals.

13.2 The Consultant may submit a modified Proposal or a modification to any part of it at any time prior to the proposal submission deadline. No modifications to the Technical or Financial Proposal shall be accepted after the deadline.

14. Preparation 14.1 While preparing the Proposal, the Consultant must give particular attention to the following: of Proposals

- If a Consultant considers that it may enhance its expertise for the assignment 14.1.1 by associating with other consultants in the form of a Joint Venture or as Subconsultants, it may do so.
- 14.1.2 The Client may indicate in the **Data Sheet** the estimated Key Experts' time input (expressed in person-month) or the Client's estimated total cost of the assignment, but not both. This estimate is indicative and the Proposal shall be based on the Consultant's own estimates for the same.
- If stated in the Data Sheet, the Consultant shall include in its Proposal at 14.1.3 least the same time input (in the same unit as indicated in the **Data Sheet**) of Key Experts, failing which the Financial Proposal will be adjusted for the purpose of comparison of proposals and decision for award in accordance with the procedure in the Data Sheet.
- 14.1.4 For assignments under the Fixed-Budget selection method, the estimated Key Experts' time input is not disclosed. Total available budget, with an indication whether it is inclusive or exclusive of taxes, is given in the Data Sheet, and the Financial Proposal shall not exceed this budget.

15. Technical 15.1 The Technical Proposal shall be prepared using the Standard Forms provided in **Proposal Format** Section 3 of the RFP and shall comprise the documents listed in the Data Sheet. The Technical and Content Proposal shall not include any financial information. A Technical Proposal containing material financial information shall be declared non-responsive.

> 15.1.1 Consultant shall not propose alternative Key Experts. Only one CV shall be submitted for each Key Expert position. Failure to comply with this requirement will make the Proposal non-responsive.

15.2 Depending on the nature of the assignment, the Consultant is required to submit a Full Technical Proposal (FTP), or a Simplified Technical Proposal (STP) as indicated in the **Data Sheet** and using the Standard Forms provided in Section 3 of the RFP.

16. Financial The Financial Proposal shall be prepared using the Standard Forms provided in 16.1 Section 4 of the RFP. It shall list all costs associated with the assignment, including (a)

a. Price Adjustment	16.2 For assignments with a duration exceeding 18 months, a price adjustment provision for foreign and/or local inflation for remuneration rates applies if so stated in the Data Sheet .			
b. Taxes	16.3 The Consultant and its Sub-consultants and Experts are responsible for meeting all tax liabilities arising out of the Contract unless stated otherwise in the Data Sheet . Information on taxes in the Client's country is provided in the Data Sheet .			
c. Currency of Proposal	16.4 The Consultant may express the price for its Services in the currency or currencies as stated in the Data Sheet . If indicated in the Data Sheet , the portion of the price representing local cost shall be stated in the national currency.			
d. Currency of Payment	16.5 Payment under the Contract shall be made in the currency or currencies in which the payment is requested in the Proposal.			

C. Submission, Opening and Evaluation

17. Submission,
 Sealing, and
 Marking of
 Proposals
 17.1 The Consultant shall submit a signed and complete Proposal comprising the documents and forms in accordance with ITC 10 (Documents Comprising Proposal). Consultants shall mark as "CONFIDENTIAL" information in their Proposals which is confidential to their business. This may include proprietary information, trade secrets or commercial or financially sensitive information. The submission can be done by mail or by hand. If specified in the Data Sheet, the Consultant has the option of submitting its Proposals electronically.

17.2 An authorized representative of the Consultant shall sign the original submission letters in the required format for both the Technical Proposal and, if applicable, the Financial Proposal and shall initial all pages of both. The authorization shall be in the form of a written power of attorney attached to the Technical Proposal.

17.2.1 A Proposal submitted by a Joint Venture shall be signed by all members so as to be legally binding on all members, or by an authorized representative who has a written power of attorney signed by each member's authorized representative.

17.3 Any modifications, revisions, interlineations, erasures, or overwriting shall be valid only if they are signed or initialed by the person signing the Proposal.

17.4 The signed Proposal shall be marked "ORIGINAL", and its copies marked "COPY" as appropriate. The number of copies is indicated in the **Data Sheet**. All copies shall be made from the signed original. If there are discrepancies between the original and the copies, the original shall prevail.

17.5 The original and all the copies of the Technical Proposal shall be placed inside a sealed envelope clearly marked "**TECHNICAL PROPOSAL**", "[Name of the Assignment]", [reference number], [name and address of the Consultant], and with a warning "**DO NOT OPEN UNTIL [INSERT THE DATE AND THE TIME OF THE TECHNICAL PROPOSAL SUBMISSION DEADLINE]**."

17.6 Similarly, the original Financial Proposal (if required for the applicable selection method) and its copies shall be placed inside of a separate sealed envelope clearly marked "FINANCIAL PROPOSAL" "[Name of the Assignment]", [reference number], [name and address of the Consultant], and with a warning "DO NOT OPEN WITH THE TECHNICAL PROPOSAL."

17.7 The sealed envelopes containing the Technical and Financial Proposals shall be placed into one outer envelope and sealed. This outer envelope shall be addressed to the Client and bear the submission address, RFP reference number, the name of the assignment, the Consultant's name and the address, and shall be clearly marked "Do Not Open Before [insert the time and date of the submission deadline indicated in the Data Sheet]".

17.8 If the envelopes and packages with the Proposal are not sealed and marked as required, the Client will assume no responsibility for the misplacement, loss, or premature opening of the Proposal.

17.9 The Proposal or its modifications must be sent to the address indicated in the **Data Sheet** and received by the Client no later than the deadline indicated in the **Data Sheet**, or any extension to this deadline. Any Proposal or its modification received by the Client after the deadline shall be declared late and rejected, and promptly returned unopened. 18. Section 6. Fraud and Corruption

(This Section 6, Fraud and Corruption <u>shall not</u> be modified)

1. Purpose

1.1 The Bank's Anti-Corruption Guidelines and this annex apply with respect to procurement under Bank Investment Project Financing operations.

2. Requirements

2.1 The Bank requires that Borrowers (including beneficiaries of Bank financing); bidders (applicants/proposers), consultants, contractors and suppliers; any sub-contractors, sub-consultants, service providers or suppliers; any agents (whether declared or not); and any of their personnel, observe the highest standard of ethics during the procurement process, selection and contract execution of Bank-financed contracts, and refrain from Fraud and Corruption.

2.2 To this end, the Bank:

 - (a) deliberately destroying, falsifying, altering, or concealing of evidence material to the investigation or making false statements to investigators in order to materially impede a Bank investigation into allegations of a corrupt, fraudulent, coercive, or collusive practice; and/or threatening, harassing, or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; or
 - (b) acts intended to materially impede the exercise of the Bank's inspection and audit rights provided for under paragraph 2.2 e. below.
- b. Rejects a proposal for award if the Bank determines that the firm or individual recommended for award, any of its personnel, or its agents, or its sub-consultants, sub-contractors, service providers, suppliers and/ or their employees, has, directly or indirectly, engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices in competing for the contract in question;
- c. In addition to the legal remedies set out in the relevant Legal Agreement, may take other appropriate actions, including declaring misprocurement, if the Bank determines at any time that representatives of the Borrower or of a recipient of any part of the proceeds of the loan engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices during the procurement process, selection and/or execution of the contract in question, without the Borrower having taken timely and appropriate action satisfactory to the Bank to address such practices when they occur, including by failing to inform the Bank in a timely manner at the time they knew of the practices;
- d. Pursuant to the Bank's Anti- Corruption Guidelines and in accordance with the Bank's prevailing sanctions policies and procedures, may sanction a firm or individual, either indefinitely or for a stated period of time, including by publicly declaring such firm or individual ineligible (i) to be awarded or

otherwise benefit from a Bank-financed contract, financially or in any other manner;¹ (ii) to be a nominated² sub-contractor, consultant, manufacturer or supplier, or service provider of an otherwise eligible firm being awarded a Bank-financed contract; and (iii) to receive the proceeds of any loan made by the Bank or otherwise to participate further in the preparation or implementation of any Bank-financed project;

e. ³ Inspections in this context usually are investigative (i.e., forensic) in nature. Draft Terms of Reference (ToR) 'Revival of Assam State Agricultural Marketing Board' under World Bank aided Assam Agribusiness and Rural Transformation Project (APART)

BACKGROUND:

- 1. Government of Assam (GoA), through the Government of India has secured a loanof US\$200 million from the World Bank (W.B.) for implementation of the proposed Assam Agribusiness and Rural Transformation Project (APART), which is currently inadvanced stages of preparation. The Project Development Objective (PDO) is to 'Increase value-added and improve resilience of selected agriculture value chains, focusing on smallholder farmers and agro-entrepreneurs and to advance Assam's COVID-19 response.'
- 2. The project will achieve the proposed PDO by: (i) promoting investments in agri-enterprises, reducing the business and transaction costs, facilitating access to finance for agribusiness entrepreneurs, and, where appropriate, push for process, regulatory and/or policy change; (ii) supporting the development of a modern agri supply chain; improved Information Communication Technologies (ICT) based farm information and intelligence services, and alternative marketing channels; and (iii) improving producers' access to knowledge, technologies and infrastructure so that they are able to respond to market opportunities and climate variability.
- 3. There are 4 (four) components to the APART. **The first component-A is 'Support to Agri enterprise Development'**, with sub-components being (i) enhancing the State's capacity to attract private investments, (ii)setting up of an Agribusiness Enterprise Development and Promotion Facility (EDPF) (iii) investment fund support, (iv) establishing stewardship councils. **The second component-B is 'facilitating agro cluster development'** with the sub-components being (i) support establishment of cluster level industry associations, (ii) supply chain support, **The third component is 'Fostering Market-led Production and Resilience Enhancement'** with the sub-components being (i) promoting climate resilient technologies and their adoption , (ii) facilitating market linkages through market intelligence and product aggregation, and (iii) facilitating access to and responsible use of financial services. **The fourth component is 'Project Management, Monitoring and Learning'**.
- 4. The project would support value addition in the production and post-harvest segments of selected agriculture value-chains; facilitate agribusiness investments through inclusive business models that provide opportunities to smallholder farmers as well as stimulate the establishment of new small and medium agribusiness enterprises; and support resilience of agriculture production systems in order to better manage increasing production and commercial risks associated with climate change, in the targeted districts. The project would adopt a cluster and value chain strategy in the targeted districts to generate economies of scale; promote vertical and horizontal links between local agricultural enterprises; enable diffusion of innovations; leverage network externalities; and channel public support for services and infrastructure. The project would enable all the value chain participants to develop competitive and innovative offerings that meet market demands rapidly and successfully.
- 5. A key project thrust will be on enhancing agglomeration of producers to improve economies of scale in processing and marketing. The project will support focused commodity productivity enhancement (including value and volumes) through essential technology transfer in production and improved post-harvest and market operations and also explore and pilot possible financing modalities to support entrepreneurship and agri-business. APART will leverage the natural resource advantages of the State as well as improve the agribusiness investment climate. In particular, focus will be on climate resilient market-led production, agribusiness, logistics infrastructure, and MSME finance and insurance.
- 6. Project beneficiaries include farmers, Farmer Producer Companies (FPCs), and agri-entrepreneurs, especially in the MSME segment and other value chain participants in the targeted districts.
- 7. The project also aims to establish a modern supply chain, which prevents wastage and value erosion, and

allows farmers and agro- entrepreneurs to access to more distant markets within a reasonable time. The activities to be financed for supply chain support include: (i) improving rural access roads that are connected to the clusters; (ii) modernizing and upgrading the warehouses, including issuing of warehouse receipts; (iii) upgrading and modernizing of agricultural wholesale markets

- 8. The Assam State Agricultural Marketing Board (ASAMB) along with 24 nos. of Market Committees (MCs) had been constituted under the Assam Agriculture Produce Market Act, 1972 (AAPM Act,1972) for proper implementation of various provisions of the said Act.
- 9. A number of developments in agricultural marketing systems over the last four decades have necessitated bringing in necessary reforms in the functioning of markets in the State for improving market efficiency, integration of markets and ensuring reasonable returns to producer-sellers by incorporating the provisions for establishment of private markets, farmer-consumer markets, special market, direct marketing, electronic marketplace, provisions for single unified license across the State, incorporation of single-point levy of market fee, enabling barrier-free movement of agricultural commodities throughout the State.
- 10. Therefore, Government of Assam has recently passed the Assam Agricultural Produce and Livestock Marketing (Promotion and Facilitation) Act, 2020 for bringing among others the above-mentioned necessary reforms in the functioning of markets in the State for improving market efficiency, integration of markets and creating an enabling environment to ensure reasonable returns to producers-sellers and ease of doing business for both the producers-sellers and buyers through cashless transactions.
- **11.** With the enactment of the new AAPLM Act, 2020, the collection of market fee would be confined to market yards only. Moreover, due to the provision of single point levy of market fee the revenue of ASAMB would be gone down drastically. Even before the enactment of the aforesaid Act, ASAMB is presently not in a position to manage salary to its employees.
- **12**. In the light of the above, Govt. of Assam now intends to apply a portion of the loan to commission a consultancy assignment for a study on revival and revamping of ASAMB, its Market Committees and regulated markets in the state of Assam. While the contract will be signed by CEO, ASAMB payments for reports based on certification by ASAMB shall be made directly by ARIAS Society to the Consulting firm.

OBJECTIVE OF THE ASSIGNMENT:

13. The broad objective of the consultancy assignment isto prepare a revival plan for ASAMB as a viable and self sustained organization, to enable it to function as a lead sector management organization for efficient service delivery to the stakeholder in the field of agricultural marketing in the state under the provisions of the AAPLM Act, 2020.

SCOPE OF THE ASSIGNMENT AND THE TASKS TO BE CARRIED OUT BY THE CONSULTANCY FIRM:

- 14. The overall scope of assignment would include (i) a detailed study and analysis of the present status and functioning of ASAMB and Regulated Market Committees thereunder; (ii) study of the prospectiverole and responsibilities of ASAMB as per the provisions of AAPLM Act, 2020; (iii) based on the above, prepare a comprehensive and implementable revival plan for ASAMB to transform it into a self-sustaining organization in the long run.
- **15**. The Consultancy agency would undertake the following tasks:
 - a. Review the recommendations of earlier studies on wholesale agricultural markets and marketing as well as the ASAMB and prepare a strategy outline for wholesale agricultural market development in Assam. The results of this assessment would feed into the reorganizations recommendations for the Board from a strategic perspective.
 - b. Critically review and analyze the present status and functioning of ASAMB, covering-

- i. The policies, mandate, vision and mission, byelaws if any, governance and administrative architecture including the progress and accomplishments of the schemes /activities implemented by ASAMB;
- ii. Organizational structure, existing &sanctioned strength of employees including present and future human resource requirement etc;
- iii. Status of movable and immovable assets (type, number, present usage, future requirement etc);
- iv. Account statement indicating capital & revenue receipt, expenditure for last five years and an assessment of audit reports, key observations etc;
- v. Funding support from various government and non-government organizations and programmes implemented thereof; access to and certainty of financial resources for future;
- vi. Existing and potential future sources of revenue generation for sustenance;
- vii. Performance level of ASAMB in relation to the existing infrastructure, financial resources, human resource in the organisation and reasons for underperformance, if any;
- viii. Competency levels (educational qualifications, technical qualifications, experience and soft skills etc) of employees of ASAMB vis-à-vis the designations and duties assigned, dedication towards work, aspirations towards organizational objectives and need for capability enhancement. **In addition**, *preparing a note of anticipated management capacity requirements that may be needed to keep up with advances in modern electronic systems, innovations in physical delivery infrastructure as well as expected investments in marketing and road infrastructure.Accordingly, working out a training and capacity building plan for the ASAMB employees.*
- c. Undertake a critical assessment of the present model of functioning of the similar but reasonably successful organizations and indicate ways and means of replicating relevant ones from these models in the organisation, structure and functioning of ASAMB and making it a financially sound self-sustaining institution;
- d. Indicate the learnings from the past performance of ASAMB, where it worked and where it did not work;
- e. Understand how operations of agricultural markets can be improved with the support of ASAMB while ensuring fair and remunerative prices to the farmers through transparent price discovery, transaction and processes, inculcating Good Agricultural Marketing Practices (GAMPs), electronic trading etc to reduce losses and bring efficiency in market operations;
- f. In preparation of the wholesale development strategy outline, comment on implementation issues emanating from recent advancements in the development of Farmer Producer Companies (FPCs) and electronic markets.
- g. Suggesting institutional reforms with respect to Board as well as Regulated Market Committees under the ambit of ASAMB to streamline operations like revenue collections, documentation, record keeping, ensuring competition, and to facilitate Regulated Market Committees to serve as a service organization rather than just a facilitator of transaction and a cess/market fee collection entity.
- h. Documenting other possible support which can be provided by ASAMB to farmers and other value chain players in better and efficient marketing of agricultural produce and inputs, e.g. in terms of training, capacity building, dissemination of market information and intelligence, facilitating e-trading through digital/electronic platforms, postharvest management to minimise losses, quality preservation and value addition, branding etc
- i. Prepare an outline of a strategy for wholesale market development for Assam and make necessary recommendations on how to empower ASAMB and RMCs to be made as the agencies solely responsible for development of wholesale markets.
- *j.* Provide strategy for removing retail market from the remit of RMC since retail trades activities are being managed by Panchayat and also identify any possible implications for resultant land reallocations and process reforms.
- k. Study the gaps in the agricultural marketing for efficient intervention of ASAMB and suggestion thereof.
- l. Provide an assessment of anticipated management capacity requirements that may be needed to keep up with advances in modern electronic systems, innovations in physical delivery infrastructure as well as expected investments in marketing and road infrastructure;
- m. Provide a realistic Vision Plan for ASAMB in terms of structure, composition, hierarchies, governance, management, administration and service delivery;

- n. Make a realistic assessment of the scope for inclusion of ASAMB as a sector management organization and a partner institution for implementing ongoing/upcoming projects/schemes like Externally Aided Projects (EAPs), Central Scheme (CS), Centrally Sponsored Scheme (CSS), State Owned Priority Development (SOPD) Scheme etc with a view to supporting Agri-marketing activities in the agriculture sector;
- o. Based on the above analysis and by carrying out backward and forward linkage assessments, workout the best possible strategies for reviving ASAMB and prepare a realistic action plan with clear-cut timelines, responsibilities, resource requirements, source of funding along with a road-map.
- p. Carry out a comparative review of benefits and costs for organization solutions, which are alternative to ASAMB revival option.

 - a. personal/direct interaction with all stakeholders (including the farmers & traders of agri markets of the state) either directly or indirtectly associated with agri-marketing activities.

Confidentiality** The Consultants shall not, during the term of this Contract and within two years after its expiration, disclose any proprietary or confidential information relating to the Services, this Contract or the Client's business or operations without the prior written consent of the Client.
